MY NAME IS BUKOLA ORIOLO AND THIS IS MY STORY

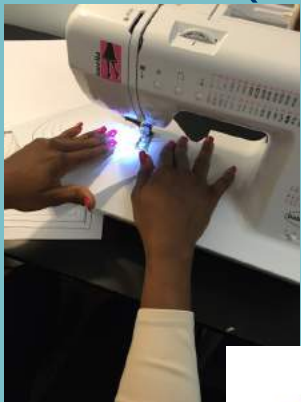
- Born and raised in Nigeria

- Published Imprisoned book and named Change Maker by Minnesota Women's Press in 2009
- Produce and host Imprisoned Show since 2010 and founded The Enitan Story in 2013
- Appointed Member, U.S. Advisory Council on Human Trafficking by President Barack Obama in 2015

THE U.S. ADVISORY COUNCIL ON HUMAN TRAFFICKING

Roles & Responsibilities

The U.S. Advisory Council on Human Trafficking was appointed in December 2015 to implement the Survivor Empowerment Act to:

- Provide recommendations to the U.S. Government to strengthen U.S. federal policy and programming efforts that reflect the best practices in the field.
- Bring expertise from personal experiences of human trafficking as a result of ongoing work and leadership against human trafficking in various local communities.
- Work with the Department of State Trafficking in Person's Office to create a structure that will enable the Advisory Council give its best service to the U.S. government and the community at large.
- Represent the diverse population of human trafficking survivors across the United States.
- Gather information from federal agencies, state, and the community for its report to the President's task force.

THE U.S. ADVISORY COUNCIL ON HUMAN TRAFFICKING

Roles & Responsibilities

The U.S. Advisory council was appointed in December 2015 and the purpose of this appointment is the implementation is Survivor Empowerment Act to:

- Review Federal Government policy and programs intended to combat human trafficking, including programs relating to the provision of services for victims and serve as a point of contact for Federal agencies reaching out to human trafficking survivors for input on programming and policies relating to human trafficking in the United States.
- Formulate assessments and recommendations to ensure that policy and programming efforts of the Federal Government conform, to the extent practicable, to the best practices in the field of human trafficking prevention.
- Provide advice and recommendations to the Senior Policy Operating Group and the President's Interagency Task Force to Monitor and Combat Trafficking.
- Submit a report that contains the findings derived from the reviews conducted. Publish an annual report to inform federal government agencies on ways to achieve this goal.

THE U.S. ADVISORY COUNCIL ON HUMAN TRAFFICKING

Shaping Services to better serve human trafficking survivors

The U.S Advisory council will help to shape services by:

- Relying on community members for feedback, suggestions, comments, and questions.
- Engaging in community activities to open dialogue that will promote effective services in the community.
- Gathering information from public convening and roundtable discussions.
- Sharing and exchanging information through one-on-one interaction with fellow survivors, service providers, law enforcement, stakeholders, and the public.
